



Certified Recovery Specialist (CRS) Training Series 2022

The CRS/CFRS training series will be held on Saturdays and Sundays over five weeks beginning 09/03/22 and concluding 10/02/22. The training is funded by DDAP and hosted by Crawford County Drug & Alcohol Executive Commission. There is no cost to attend. Priority seating will be given to Crawford County residents until 8/12/22. Upon completion of the training, funding assistance is available, as may be necessary for Crawford County residents, for initial application fee (\$150 for **EITHER** CRS or CFRS credential).

- Once an account is created candidates must apply for the class at <https://www.pacertboard.org/class/recovery-specialist-120>
- The class is currently set to "private" and the password to access the application is **CCDAEC**
- Students must also have a login on DDAP Training Management System. You MUST set the account up at <https://apps.ddap.pa.gov/tms/Logon.aspx>
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
