

Certified Recovery Specialist (CRS) Training Series 2022

The CRS/CFRS training series will be held over five weeks beginning 11/21/22 and concluding 12/20/22. The training is funded by TCWIB's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Indiana, Butler, and Armstrong County residents until 10/24/22. Upon completion of the training, funding assistance is available for application/initial certification fees (\$150 for either CRS/CFRS).

- Candidates must begin by creating an account at https://www.pacertboard.org/
- Once an account is created candidates must apply for the class at https://www.pacertboard.org/class/recovery-specialist-139
- The class is currently set to "private" and the password to access the application is TCWIB
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
