



Certified Recovery Specialist (CRS) Training Series 2023

The CRS/CFRS training series will be held over five weeks beginning 1/19/23 and concluding 2/17/23. The training is funded by Partner4Work's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Allegheny County residents until 12/16/22. Upon completion of the training, funding assistance is available, as may be necessary, for application fees for initial certification fees (\$150 for either CRS/CFRS).

- The class is currently set to "private" and the password to access the application is **Partner4Work**
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
