



## Certified Recovery Specialist (CRS) Training Series 2023

The CRS/CFRS training series will be held over six weeks beginning 4/15/23 and concluding 5/21/23. We will be off for Mother's Day weekend. The training is funded by the Pennsylvania Department of Drug & Alcohol Programs (DDAP) and hosted by Erie County Office of Drug & Alcohol Abuse. There is no cost to attend. Priority seating will be given to Erie County Residents until 3/12/23. Erie County SCA is offering a contingency management aspect to our CRS training. Erie County residents who complete the CRS training course, test within 90 days of completion, and pass their exam will receive a \$250 gift card. Application fees for certification (\$150 for either CRS/CFRS or \$300 for both) and any testing related costs will be paid for by ECOD&A for Erie County residents. Any non-Erie County residents' fees will need to be assumed by the student or the referring employer.

- Once an account is created candidates must apply for the class at <https://www.pacertboard.org/class/recovery-specialist-169>
- The class is currently set to "private" and the password to access the application is **ECOD&A**
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

\*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.

	The ninth session of the RSC will conclude discussion on advocacy and begin a discussion on cultural competency.

	The tenth and final session in the RSC will conclude the discussion of cultural competency and discuss safety and self-care for the recovery specialist.
