



Certified Recovery Specialist (CRS) Training Series 2023

The CRS/CFRS training series will be held over 10 days beginning 4/10/23 and concluding 4/21/23. The training is funded by PMHCA's recently awarded Pennsylvania Commission on Crime and Delinquency (PCCD) FY 2022 Violence Intervention & Prevention (VIP) Competitive Grants Program project titled **Elizabethtown Peer Support Co-Responder Program**.

There is no cost to attend. Testing/PCB application fees will also be covered under this project at no cost to the attendees. Additional time will be dedicated (outside of class hours) for any attendee who is in need of job readiness skill development, networking, and workforce engagement opportunities.

- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.
