Certified Recovery Specialist (CRS) Training Series 2023

The CRS/CFRS training series will be held over 10 days beginning 5/22/23 and concluding 6/20/23. Please note, there will be no class on Memorial Day. The training is funded by The Wright Center's ARC INSPIRE initiative **Project PROGRESS**. There is no cost to attend. Priority seating will be given to residents of Lackawanna, Luzerne, Pike, Susquehanna, Wayne, and Wyoming counties until 4/23/23. Students **will not** be responsible for the \$150 testing/PCB application fee. This will be covered by The Wright Center's project under the ARC INSPIRE initiative.

- The class is currently set to "private" and the **case sensitive** password to access the application is **Project PROGRESS**
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
