Certified Recovery Specialist (CRS) Training Series 2023

The CRS/CFRS training series will be held over 10 days beginning 5/25/23 and concluding 6/23/23. The cost to attend is \$940/person. Invoice will be sent upon review of application. Payment due prior to approval. No charge for ACH payments. For payments via Apple Pay, Venmo, PayPal, or credit/debit card, a 2.9% processing fee will be added. Student/employer will be responsible for application/testing fee of \$150.00 (not including pre-enrollments).

- Candidates must begin by creating an account at <https://www.pacertboard.org/>
- Once an account is created candidates must apply for the class at <https://www.pacertboard.org/class/recovery-specialist-180>
- The class is currently set to “public” and the **case sensitive** password to access the application is **Steelers N@tion**
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*Visitors MUST check-in with security at front desk before proceeding to elevator. No food or drink is permitted in training room. Parking will be announced prior to first day.

**Masks are REQUIRED once inside the hospital. Parking in James St. Garage adjacent to the hospital (\$20/day) or metered parking.
