The CRS/CFRS training series will be held over 10 days beginning 9/18/23 and concluding 9/29/23. The training is funded by PaPSC's ARC POWER initiative **Building a Peer Support Workforce in PA**. There is no cost to attend. Priority seating will be given to residents of the 52-county PA ARC region counties. Students WILL NOT be responsible for the \$150 testing/PCB application fee. This will be covered by PaPSC's grant.

- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.
- Application/testing fee of \$150.00 will be covered by PaPSC.
