Certified Recovery Specialist (CRS) Training Series 2024

The CRS/CFRS training series will be held over five weeks beginning 3/14/24 and concluding 4/19/24. We will not be meeting 3/28/24 or 3/29/24 due to the Easter holiday. The training is funded by Partner4Work's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Allegheny County residents who are veterans, mothers, or re-entrants until 2/21/24. Upon completion of the training, funding assistance is available, as may be necessary, for initial application and certification fees (\$150 for either CRS/CFRS).
