Certified Recovery Specialist (CRS) Training Series 2024

The CRS/CFRS training series will be held over two weeks beginning 8/12/24 and concluding 8/23/24. The training is funded by Partner4Work's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Allegheny County residents who are veterans, mothers, or re-entrants until 7/14/24. Upon completion of the training, funding assistance is available, as may be necessary, for initial application and certification fees (\$150 for either CRS/CFRS).

- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
