



Certified Recovery Specialist (CRS) Training Series 2024

The CRS/CFRS training series will be held over five weeks beginning 11/5/24 and concluding 12/4/24. The training is funded by TCWIB's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Indiana, Butler, and Armstrong County residents until 10/6/24.

Upon completion of the training, funding assistance is available for application fees for initial certification fees (\$150 for either CRS/CFRS).

- Once application is reviewed, you will be contacted via phone to conduct a pre-screening to determine eligibility, so please be sure to include working number
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
