The CRS/CFRS training series will be held over 10 days beginning 4/13/26 and concluding 4/24/26. The training is funded by PaPSC's ARC POWER initiative **Project POWER** and Wayne Pike Workforce Alliance's ARC **Recovery to Work** initiative. - Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.
