The CRS/CFRS training series will be held over five weeks beginning 7/23/26 and concluding 8/21/26. The training is funded by TCWIB's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Butler, Armstrong, and Indiana County residents who are veterans, mothers, and/or reentrants until 6/14/26. Upon completion of the training, funding assistance is available for application fees for initial certification fees (\$150 for either CRS/CFRS).

- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.
