

Certified Recovery Specialist (CRS) Training Series 2026

The CRS/CFRS training series will be held over five weeks beginning 9/16/26 and concluding 10/15/26. The training is funded by Southwest Corner Workforce Development Board's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Beaver, Greene, and Washington county residents who meet the CRS requirements until 8/7/26.

Upon completion of the training, funding assistance is available for application fees for initial certification fees (\$150 for either CRS/CFRS).

- Once application is reviewed, you will be contacted via phone to conduct a pre-screening to determine eligibility, so please be sure to include working number
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:45 am and expect to be in class to 5:00 pm each day.

	The fourth session of the RSC will continue the discussion of Motivational Interviewing and review the Stages of Change. Ethical responsibility and professionalism will also be discussed.

	The fifth session of the RSC will conclude the discussion on ethics and professionalism. The day will conclude with beginning the discussion on Substance Use Knowledge.

	The eighth session of the RSC will conclude discussion of recovery planning and collaboration. Additionally, other types of support a recovery specialist can provide will be reviewed, including non-clinical support groups, digital recovery support, and advocacy.

	The ninth session of the RSC will conclude discussion on advocacy and begin a discussion on cultural competency.	
10/15/2026	RSC10 - Cultural Competency, Safety and Self-Care	7
	The tenth and final session in the RSC will conclude the discussion of cultural competency and discuss safety and self-care for the recovery specialist.
