



Certified Recovery Specialist (CRS) Training Series 2026

The CRS/CFRS training series will be held over two weeks beginning 10/26/26 and concluding 11/6/26. The training is funded by TCWIB's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Indiana, Butler, and Armstrong County residents who are veterans, mothers, or re-entrants until 9/20/26. Upon completion of the training, funding assistance is available for application fees for initial certification fees (\$150 for either CRS/CFRS).

- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.
